Kids Take Center Stage at Upcoming Art Show

PathWays PA's 4th Annual Charity Art Show & Auction is quickly approaching. On Sunday, March 27, from 3-7PM in the Valley Forge Radisson's Waterford Ballroom, PathWays PA and some of the region's most talented artists will again come together to host great art for a great cause!

In addition to original fine art, this year's event will also include jewelry, photography and ceramics. Even more exciting, the art show will feature original artwork by the children who reside at our Center for Families (CFF) in Wawa, PA. The CFF is a supervised residential program for homeless mothers who wish to avoid foster care placement for their children. The staff at the CFF work with moms to promote self-sufficiency; education; parenting and life skills; self-esteem and movement towards life goals. The CFF also promotes the healthy physical, emotional and social development of children through early childhood development programs; enrollment and maintenance of school aged children in the local school system; an after-school homework club and summer activities.

"Children have fun creating art, and can express themselves this way," says Lisa Prinzo, an artist participating in this year's event. "Art opens the doors to creativity and skill."

Artist and PathWays to the Stars Art Show & Auction Co-coordinator Cathy Peluso agrees: "Artwork allows a child to express their imagination, to show their colors."

The children at the CFF will spend a day working with Peluso and renowned artist Dane Tilghman to create their pieces for the event. Tilghman, one of the most prolific and talented African-American artists of our generation, is excited to introduce a new creative outlet to the children. "I think it's a good thing for the kids to participate in the show. It will also give them a sense of accomplishment, this is likely the first time they have shown their art in an art show alongside professional artists." Tilghman is no stranger to having his art appraised by the public. He has had works presented to such notables as actor Ossie Davis, comedian Bill Cosby and political leader Nelson Mandela. Additionally, Tilghman has been commissioned by the Philadelphia Phillies to create work for Citizens Bank Park, and by the Atlanta Braves for a mural at Turner Field. "I'm sure participating in the art show will make the kids feel great. It will also contribute towards their own well-being by helping us raise funds."

Last year's annual art show & auction raised in excess of \$13,000. While we hope to far exceed that number this time around, Lisa Prinzo put it best: "The most exciting thing about this year's event will be the addition of children's art. We mustn't forget the reason for the show, which is helping families to better their lives. Featuring children's art will remind us of the cause."

I am amazed by the creativity and energy of children perhaps more than anything I see in my job at PathWays PA. Many of the kids who have been touched by our agency have been exposed to significant pain, loss and trauma during their lives. But, I find inspiration in their spirit to move through these challenges and thrive when their caregivers are given the support they need to be positive role models. The moms who progress through our programs are on the road to self-sufficiency, but they also serve as a beacon for their children to reach higher and to be successful in school, extra-curricular activities and eventually as productive and happy adults. PathWays PA is the connector that helps a woman change her life through self-empowerment. We provide families with the tools they need to move along the continuum from poverty to self-sufficiency. We have worked with moms who have not completed high school and have witnessed the turnaround in their lives as they complete their GEDs and in many instances move onto post-secondary education. This is the magic I find in our formula for success and it has brought me joy to witness this phenomenon throughout my years at PathWays PA.

The artwork of our kids will be displayed right alongside paintings by famous and talented regional artists. Free Tax Preparation for Low-income Families

PathWays PA understands the importance of tax refunds for working families, particularly during these challenging economic times. That's why we've established the Volunteer Income Tax Assistance (VITA) program, which offers free tax preparation by IRS-trained tax preparers for families earning \$50,000 or less.

Consumers are often lured into services provided by tax preparation companies by a promise of quick tax returns. Some companies go as far as offering same-day cash, in the form of a Return Anticipation Loan (RAL), a loan given to the consumer based on what the company thinks the tax refund will be. While the idea of quick cash in hand is appealing, consumers are often unaware of traps set by some tax preparation companies, such as high interest on RALs and large preparation fees. In the end, these "loans" may end up costing the family hundreds, or even thousands of dollars, money they simply cannot afford to pay.

PathWays PA's VITA program provides low-income households a safe, effective and free alternative to tax preparation companies. By using IRS-trained tax preparers, the VITA program volunteers know how to look for those specific tax credits which benefit low-income families. In 2010, the VITA program prepared over 1,600 taxes, totaling \$2.7 million in returns to clients and their families. This year, PathWays PA's VITA program received a prestigious IRS VITA Grant, as well as funding from the National Community Tax Coalition to promote our focus on building financial resources during tax time. We take the convenience of free tax preparation one step further by offering the VITA program at three sites in Delaware County, along with various sites in West Philadelphia and North Philadelphia. The program also provides over 80 mobile tax preparation sites, bringing services to employers and organizations whose employees qualify for Earned Income Tax Credits (EITC).

Who We Are Interviews

Janet Lane-Margetich, Senior Manager of Human Resources, PathWays PA



Tell us about your education. I received my Bachelor of Science degree from Neumann University in Business Management, and my certification as a Professional in Human Resources from Villanova University.

How long have you been at PathWays PA? It will be seven years this June.

Tell us your position and a little bit about the work you do. I am the Senior

Manager of Human Resources. My office is responsible for the administration and oversight of all employees' recruitment, pre-employment screenings, new employee orientations, health and welfare benefits, workers compensation, unemployment compensation, etc. We also ensure all staff employment records are in compliance with agency requirements and program regulations as well as city, state and federal laws. Overall, we do all that we can to assist employees and management with a variety of issues that fall under the scope of Human Resources.

What is your favorite thing about your job? My co-workers. I have two excellent assistants, Chris Stoddard and Linda Dougherty, both of whom are invaluable in the functioning of HR. I report to Maryann Calhoun who is a

true pleasure to work for. Maryann offers great support, knowledge and has a great ability to make the most complicated situations manageable. All of the staff and management here at PathWays PA are wonderful. Everyone is so dedicated and committed to the work that they do. Having come from a corporate background, I find great personal fulfillment and satisfaction in knowing that at the end of the day the employees I support are helping others make a difference in their lives.

What is the most challenging thing? There are many challenges in HR, and they can change moment to moment. We have recently seen many changes in both State and Federal law, as well as program regulations. All of these changes have a large impact on our day-to-day functions here in HR, and it is critical for us to be aware and ensure that we are in compliance at all times.

How does PathWays PA make a difference? PathWays PA is a great organization with a broad spectrum of programs which benefit many people in many ways. From helping achieve a GED, to job placement and sustainment, it's amazing how many different areas we touch upon. All of our programs are capable of impacting people's lives and making a difference. It is truly an honor to be part of such a wonderful agency!

Where were you raised? I spent the majority of my childhood in North Philadelphia. Just before high school, my family moved to Cheltenham Township, where my parents still reside.

Who or what influenced you most? My parents had the most influence on my life. They had little access to education growing up in the segregated South. Apart from God and family, which came first, educational achievements meant everything to them.

Where was your first job, and what did you do? My first meaningful employment was with Vanguard right out of college. I was hired as a Fund Accountant and maintained the records for a number of mutual funds.

What lessons did you learn from that job? I learned why attention to detail mattered. Thousands of investors were depending on me to price the funds accurately.

Where did you receive education after high school? I attended Penn State, University Park Campus, majoring in Finance and obtained my MBA at Villanova University.

What is your current job? I still work for Vanguard. I am

responsible for a number of shared services functions within our Recordkeeping Services department, that provides plan and investment administration for institutional retirement plan clients.

Why do you serve on PathWays PA's board? I wanted to serve my community in a more concrete way. I've made financial donations for over twenty years and participated in numerous volunteer events, but I'm seeking a greater sense of satisfaction that comes with helping one organization achieve its goals. Jewelry



Ceramics



Success Story

A single mother of one, 20-year-old Toni was lost and it seemed to her she faced a life without viable options for survival. She came to PathWays PA through the Transitional Living Program (TLP) which provides housing and supportive services for pregnant teens or young moms facing a life on the streets. TLP provided stability for Toni and her son, while also affording the young mother a chance to pursue her GED, look into post-secondary education, hone her child-rearing skills and develop a career plan. Once Toni settled into a secure living environment, the TLP staff referred her to another PathWays PA program - Financial Path\$. Financial Path\$ teaches low-income

participants how to manage personal finances and save money with a goal of attaining economic self-sufficiency. Case managers at Financial Path\$ worked with Toni to teach her how to comparison shop, research banking products, manage her debt and implement spending strategies to save money. Toni created a long-term plan to become debt free. She also opened a 529 College Saving account to begin saving towards her son's college education.

Through PathWays PA, Toni found a network of programs that are serving as a guide to reach stability and financial security. For the first time in her life, Toni feels like she is moving in a positive direction, and she has a realistic prospect that her son will enjoy opportunities for success unknown to her during her childhood.

Olivia Sarnor needed a way to make ends meet. After her ex-husband fell ill and was unable to provide child support for her two daughters, it was up to Olivia to supply her family with essentials, like food and vital household items. Olivia's salary as a Direct Care Worker was insufficient for maintaining a household, and the Delaware County resident needed to find another solution fast. Things were beginning to look hopeless when Olivia heard of PathWays PA. She decided to look into the agency's services for low-income families, and soon discovered that PathWays PA was the solution to her family's struggles.

At PathWays PA, Olivia worked with Family Advocate Vernice Lloyd to determine her eligibility for supportive services. Following a screening process, Vernice was able to assist Olivia with the

often intimidating and confusing Supplemental Nutrition Assistance Program (SNAP) application process. Within a few weeks, Olivia was found eligible for SNAP, a service that helped alleviate one of her family's largest monthly expenses. Now Olivia receives just over \$200 in grocery assistance each month, and this has been the determining factor in keeping her household afloat.

"Coming to PathWays PA and getting the help I needed has made buying food and running my household so much easier."

"Thank God for PathWays PA, they've been so good to me," Olivia says. "Buying groceries had become very difficult, especially while trying to support kids. Coming to PathWays PA and getting the help I needed has made buying food and running my household so much easier."

Olivia continues to work hard as a Direct Care Worker, and says she feels more financially sound because of PathWays PA. What's most important is that Olivia can now rest easy knowing that she can provide living essentials for her family.
